



FEBRUARY 2024

(Note: The following highlights are taken from the minutes of the Monday, January 15, 2024, regular Session meeting, which was held virtually using Zoom software.)

Clerk's Report: Seventy-five communicants were served on Sunday, December 3, 2023. Sixty-four communicants received communion on Sunday, January 14, 2024.

The pastor's office, adjacent to Fellowship Hall, will be kept unlocked until it is used by the new pastor.

Barb Hazlett was elected as clerk of Session and secretary for 2024; Barry Gaut was elected as treasurer for 2024; and Rick Herbster was elected as president for 2024. The secretary, treasurer and president's offices are for the church as a corporation.

The Pastor Nominating Committee (PNC) reported that the Ministry Discernment Profile (MDP) has been released and we have started to receive matches for the position of pastor. We are in the process of reviewing the matches and inviting some candidates to apply. The PNC would like Session to update our church web site with more events, pictures and videos.

Garvey Manor is in the process of adding some

independent living apartments. They made a request to our church to place an ad on our bulletin board for these apartments. Session made the decision to turn down this request.

Treasurer's Report: The treasurer's report was distributed and discussed by the Session.

Huntingdon Presbytery Report: The next meeting of Huntingdon Presbytery will be held on Saturday, January 27, 2024. Presbytery will be installing a new moderator at this meeting.

Session Team Reports (Chair)

Finance & Stewardship (Barry Gaut): For the period ending on December 30, 2023, a total of \$3,788.90 has been received for our per capita fund. This represents a 69% response, or approximately 97 of our 139 members. This year's 69% figure compares with a 2022 per capita response rate of 77%, a 2021 response rate of 86%, and a 2020 response rate of 74%.

As you can see from the table below, our church congregational giving in 2023 was about five percent (5%) less than what was received in 2022. Special giving to building projects and repairs dropped this year; total expenses were reduced by approximately \$37,000, a reflection of reduced spending on building repairs in 2023.

To date, we have received 33 individuals/families that have pledged a total of \$106,208 for the 2024

stewardship campaign. This represents an average annual pledge of \$3,218.

The 2024 Stewardship & Finance Team will consist of Jane Carothers, Barry Gaut and Sue Whitsel. They are looking for one more member from the congregation to join their team.

Congregational Care (Gail Irwin): All went well with the delivery of the Advent dinners, cookie trays and the Angel Gifts to the Presbyterian Village at Hollidaysburg.

Dates for birthday cakes at the Presbyterian Village at Hollidaysburg will be set at our February meeting.

The homebound communion schedule will also be set in February. A thank-you card was sent to Pastor Colebank for helping with communion in November and December.

A letter has been drafted explaining per capita and will be sent to the congregation.

Congregational Fellowship (Glenn Nelson): Our next coffee fellowship is Sunday, February 5th. It will be 'cherry' month in honor of the presidents and valentines.

Mission (Judy Hartzell): We served 36 guests at the December Soup on Saturday event.

An application was completed and sent to Huntingdon Presbytery to request "Hunger Fund" monies to help support our Food Pantry.

The Family Services blanket project was placed on hold until after Christmas. Blanket kits are being accumulated.

We are anticipating 50 guests for the January 20 Soup on Saturday lunch. Hot dogs and sauerkraut, fruit cups and donated desserts, as well as some delicious leftovers from the Advent dinner will be served. We will not need hot soup in January.

In December, we gave the following: Krislund Program & Staff - \$200; Special Need Fund - \$300; Soup on Saturday Provisions - \$27.85; The Door -\$264.82.

In January, we are asking for donations of canned soup and saltines or crackers for the Altoona Food

Bank. Donations of any non-perishable food items are also appreciated.

For our Food Pantry, we are requesting donations of any non-perishable food items and personal care items. No glass containers, please.

Outreach (Jane Yerty): The team is committed to continuing the scholarships for neighborhood kids for Camp Krislund and needs to raise funds to support this effort. Outreach surveyed the congregation to find out if selling hoagies is the best way to go, and alternatively, if our church family would prefer making donations. We would need to sell a large number of sandwiches to ensure profit and to offset delivery costs.

The Garden and Library are shut down for the winter, but we are investigating ways to have the upkeep of our Garden to be less labor intensive.

Our annual Yard Sale is scheduled for Saturday, April 27, 2024. The committee would like to reserve Fellowship Hall for the entire week preceding the event for setup and pricing.

We discussed with Kimberly bulletin and on-screen announcements to increase awareness of continuing donations to Family Services.

Our church's video license (\$290.64 for the year) is up for renewal. The team wondered if any other Session committees would be planning on using videos that would require license clearances. None said that they did, so Outreach will discuss the value of a license renewal.

Personnel (Bob Hollingsworth): No gift cards were distributed this month.

A question was raised concerning the nursery supervisor position. Personnel is still waiting to hear from a candidate and will reach out again for a respone.

Property (Geoff Geesey): The heating system boiler was repaired and a repair was made to the snow blower.

Two proposals from McCartney's were presented for a new office copier. It was suggested that the prices seemed high, therefore, this purchase will be researched further and addressed next month. Spiritual Enhancement (Jeanie Mollica): The youth will go bowling in January and they will have a "Battle of the Brownies" event in February. The committee introduced a new curriculum for Sunday School.

Worship (Rick Herbster): Acolytes, liturgists and ushers are in place for January.

Fundraising is underway for the church pipe organ. A chart in Fellowship Hall is being used to keep track of the monies raised. Our organ is currently under repair and will be out of service for Lent.

Our team again discussed the "emergency phone tree" for emergencies such as bad weather. Each Worship Team member took a page from our church membership list for names of people to call in case of an emergency.

The "segue statement" between the Apostle's Creed and the Doxology will be eliminated from the morning worship service.

Our nursery attendant needs to be in the nursery at the beginning of the worship service if there are any children in the nursery at that time.

The approved communion schedule for 2024 is as follows: January 7, February 4, March 3, March 28 (Maundy Thursday), April 7, May 5, June 2, July 7, August 4, September 1, October 6 (World Communion Sunday), November 3 and December 1 (First Sunday of Advent).
